- **Approval of the Minutes of the October 5, 2022 and October 19, 2022 Board Meetings:**

Dr. Hildebrant moved to accept the minutes of the October 5, 2022 meeting. Dr. Liebow seconded the motion. The motion passed; opposed: none; recused: none; abstained: none.

- **Board Issues (Ms. McClain):**

S. McClain noted that the election process will begin next month with assembly of a Nominations Committee and call for nominations of officers for the annual election of officers to be held in January. She informed members that her term on the Board is set to end in 2023, so she does not intend to run for Chair. Dr. Hildebrant has indicated he is willing to run for Chair, so we will need one or more nominees for Vice Chair. Dr. Sproul added that her Board term is ending in 2023, so we will need a nominee for Secretary, too.

S. McClain also added the welcome of Stephanie Lorentz, the new Board member on the South Investigative Committee. Patricia Hunter will serve as her public member point person, and Dr. Robert Tortolani will serve as her physician member point person.

- **Administrative Updates (Mr. Herlihy):**

D. Herlihy provided an update on the renewal status for physicians. As of Tuesday, 2826 renewals had been submitted with less than half processed. 1281 have been processed and

1165 have been mailed. He added that a few different factors are contributing to having less than half processed. First, T.Hayes is very busy with licenses as we continue to get new applicants at high rates. Also, a significant portion of time is being spent on the phone with Licensees, as they wish to speak with someone rather than use the automated online tool for password resets. Another factor is that we lost the part-time employee who had assisted T.Hayes and have been unable to hire a replacement. There was a brief discussion about how to encourage Licensees to use the automated tool to gain access to their account rather than calling.

A reminder notice was sent out on October 24, 2022 to all of the remaining Licensees who had not had their renewals processed. The reminder also included another warning about the advertisements for CME that tend to mislead Licensees into thinking the advertised courses are required and must be purchased and completed in order to renew their licenses.

The Board Office will be closed on Veteran's Day, November 11, 2022, and for Thanksgiving, November 24 and 25, 2022.

D. Herlihy reminded the Board that he will be attending the IMLCC annual meeting in Alabama on November 7 and 8, 2022.
